(President: Kunitaro Kitamura; hereinafter “SuMi TRUST Holdings”) hereby announces that its board of directors resolved at its meeting held today to repurchase its own shares pursuant to the provision of its Articles of Incorporation in accordance with Article 459, Paragraph 1 of the Companies Act of Japan.

1. Reason for Repurchase

SuMi TRUST Holdings will repurchase its own shares in order to improve shareholder return as well as capital efficiency.
