# **Sumitomo Mitsui Trust Bank, Limited (2021 Green Bond)**

#### Introduction

In March 2021, Sumitomo Mitsui Trust Bank, Limited ("SuMi TRUST") issued a green bond (USD 500 million 5-year green bond, hereinafter the "2021 Green Bond") aimed at financing and refinancing Renewable Energy, Energy Efficiency, Clean Transportation, Pollution Prevention and Control and Green Buildings projects. In September 2023, SuMi TRUST engaged Sustainalytics to review the projects financed and refinanced with proceeds from 2021 Green Bond and provide an assessment as to whether the projects met the use of proceeds criteria and the reporting commitments outlined in the Sumitomo Mitsui Trust Bank Green Bond Framework (the "Framework"). Sustainalytics provided a Second-Party Opinion on the Framework in February 2021. This is Sustainalytics' third annual review of allocation and reporting of the green bond issued under the Framework, following a first and second reviews in September 2021 and September 2022 respectively. 3,4

#### **Evaluation Criteria**

Sustainalytics evaluated the projects and assets funded with proceeds as of March 31, 2023, based on whether the projects:

- 1. Met the use of proceeds and eligibility criteria defined in the Framework; and
- Reported on at least one key performance indicator (KPI) for each use of proceeds category defined in the Framework.

Table 1 lists the Eligibility Criteria and associated key performance indicators for the Use of Proceeds category to which the proceeds were allocated.

#### Conclusion

Based on the limited assurance procedures conducted,<sup>5</sup> nothing has come to Sustainalytics' attention that causes us to believe that, in all material respects, the reviewed projects do not conform with the use of proceeds criteria and reporting commitments in the Framework. While SuMi TRUST disclosed to Sustainalytics that the proceeds from the 2021 Green Bond were fully allocated as of March 31, 2022, Sustainalytics conducted another review in September 2023 due to changes in loan balance amount and impact reporting. SuMi TRUST has confirmed to Sustainalytics that the proceeds of the 2021 Green Bond remain fully allocated.
